On Long Island, we offer adolescents, ages 12-18, a full spectrum of services, including after-school outpatient programs in collaboration with Eastern Suffolk BOCES and Longwood High School; a Recovery High School in partnership with Western Suffolk BOCES; and a 45-bed residential program for young people in need of intensive care. We are also working with the New York State Office of Addiction and Support Services on an EQuITY grant to enhance services in Nassau and Suffolk Counties for youth between the ages of 12-25 who have substance use and co-occurring mental health disorders. Later this year, we will open our very first residential treatment program for transitional aged youth, ages 18-25, in Brentwood. This brand-new state-of-the-art facility will provide this much overlooked age group with the support they need to fight addiction and other mental health issues, help them reunite with their families, and build futures filled with hope and promise.

During this afternoon’s program you’ll have the opportunity to hear firsthand from one of our other remarkable adolescent program graduates. I hope this will help you to fully understand the positive and sustained impact that your support of Outreach has on the lives and futures of young people and their families on Long Island.
