# Protect Your SNAP!

New federal government work rules and eligibility requirements take effect November 1, 2025.

Starting November 1, based on changes from the federal government, work requirements, age limits and exemptions are changing for SNAP recipients who are 18-64 years old, living without dependent younger than 14 and who are able to work.



## FAILURE TO COMPLY WITH THESE NEW FEDERAL RULES MAY RESULT IN A LOSS OF SNAP BENEFITS.

The federal government now has different age limits for both you and your dependents if you are an Able-Bodied Adult Without Dependents (ABAWD).

#### **NEW RULES**

Your Age 18-64
Your Dependents' Age Under 14
Work Ability Able to work

To get SNAP benefits for more than three months in a three-year period, you must work at least 80 hours a month or participate in a qualified training program if you are between the ages of 18-64, have children 14 or older and are physically and mentally able.

Exemptions for veterans, homeless individuals and current or former foster youth age 18-24 have been eliminated by the federal government.

A partir del 1º de noviembre, debido a los nuevos cambios hechos por el gobierno federal los requisitos de empleo, los límites de edad y las excepciones cambiaran para todos aquellos que reciben beneficios de SNAP que se encuentren entre las edades de 18 a 64 años de edad, que no tengan dependientes menores de 14 años y que estén en condiciones de poder trabajar.

Para poder recibir beneficios de SNAP por más de tres meses en un periodo de tres años, usted deberá trabajar por lo menos 80 horas al mes o participar en un programa de capacitación aprobado si tiene entre 18 y 64 años de edad, tiene hijos de 14 años o más y esta física y mentalmente apto para trabajar.

Las excepciones para veteranos, personas sin hogar y jóvenes entre 18 a 24 años que esten o hayan estado en el sistema de crianza temporal han sido eliminadas por el gobierno federal.
